**Terms and Conditions of any booking**

1. **A booking:** A hire of a hut or gazebo space can only be confirmed after receipt of your application form and payment to Kentish Trader Limited. All reservations and bookings are subject to the lease(s) in place between Kentish Trader Limited and Canterbury City Council and traders will be required to sign the approved license for trading. All spaces or huts will be allocated by the market manager and his/her decision is final. Space will only be available to local independent businesses, food producers, designers, crafts people and artists. Kentish Trader Limited reserves the right to exclude any exhibitors who do not meet their entry criteria and their decision shall be final.
2. **Deposit.** For hut bookings one month's hire fee is required as a deposit which will cover the final month's hire fee.
3. **Payment terms.** Paid monthly and strictly on the first day of each month. Preferably by standing order but cash, BACS or cheque payable to Kentish Trader Limited is acceptable. Bank details for standing order & BACS: Kentish Trader Limited 83018301 60-23-38. No refunds will be made for cancellations or poor weather.
4. **Discounts.** There is a 5% discount for payment by standing order and a 5% discount for current members of *Produced in Kent*. No other discounts are available.
5. **Electricity usage.** Where metered, power is charged at 18p per unit or at £5 per month included in the hire charge, where not metered.
6. **End of hire:** Keys must be returned at the end of the booking period and the hut left clean and tidy. If locks are changed duplicate keys must be provided to Kentish Trader. Any repairs or cleaning required charged at cost plus 20%.
7. **Opening Times:** The Harbour Village site will be officially open every week-end and bank holiday from 10am to 5pm. Traders are also welcome to open during week-days between 10am and 5pm for no additional charge. All exhibitors are required to be open and ready to trade by 10am sharp on all open days. NO trading is permitted in January and February
8. **Rubbish:** All exhibitors are responsible for clearing away all their equipment and rubbish at the end of the day. Do not leave rubbish or packing materials anywhere on the site.
9. **Loading/Unloading:** The harbour is pedestrian only, so all exhibitors must keep their cars clear outside designated loading/unloading times (currently 7pm-9am Mon-Thurs).
10. **Professional Standards:** All exhibitors are required to maintain a friendly and professional appearance and manner to fellow traders, harbour users, visitors and customers at all times.
11. **Insurance:** All exhibitors are required to organise their own public liability insurance to the value of £5 million and have a certificate in place at the time of exhibiting.
12. **Food and Drinks:** The selling of "hot food or drinks" is only permitted in the designated Kentish food zone and must be specialist local produce for take away consumption only. The selling of "ice cream and chilled confectionary" is not permitted at any time. Any exhibitors selling food or consumables must have the appropriate food hygiene and other certification available for inspection, as required by the local authority.
13. **Health & Safety:** All exhibitors must complete a health and safety audit of their area and ensure that there is no fire, electrical or tripping hazards and that the safety of the public and fellow traders is prioritised at all times. Any concerns regarding health and safety should be reported to Kentish Trader immediately.
14. **Security.** Kentish Trader Limited accepts no liability for damage, loss or theft to the exhibitor's property or person. Exhibitors attend at their own risk and are responsible for their own insurance and security at all times. Stock is left on site at the exhibitor's risk.
15. **Failure to comply with these terms:** Failure to adhere to these terms and conditions may result in your immediate eviction from the Harbour Village and the forfeit of your deposit.
